

Chairman's Circle 2024 Terms and Conditions

- Chairman's Circle 2024 qualification begins midnight, PT January 1, 2023 through December 31, 2023 at 11:59 PM PT.
- The Chairman's Circle 2024 trip will be taken in 2024.
- Chairman's Circle can be earned by active Xyngular Distributors in good standing.
- All qualifiers are subject to Xyngular Distributor Policies & Procedures. Any violations of Policies & Procedures will disqualify participants from earning or attending the Chairman's Circle trip.
- Chairman's Circle qualifiers will be notified in January 2024 to arrange travel accommodations.
- The market value of any Xyngular trip a qualified Distributor attended will be included on annual tax reports as earnings. The Distributor is liable and accountable for all applicable taxes in accordance with Xyngular Distributor Policies & Procedures. See Section 3.19.5.
- There are many factors that account for the actual taxable value of the trip, i.e., travel, accommodations, food, excursions, etc. It is difficult to assess value of this trip currently due to unforeseen circumstances that may affect market prices. However, when Distributors are notified that they have obtained the Chairman's Circle, and estimated amount of the value of the trip will be disclosed to enable the Distributor to make appropriate tax-related decisions.
- To qualify for the Chairman's Circle trip a Distributor must achieve the requirements below in a single calendar year.
 - Personally achieve a new rank of Platinum Executive two months in a row or maintain the rank of Platinum Executive or above for 8 of the 12 months in a calendar year.
 - Be personally 120 PV qualified each calendar month of the year during the Qualification Period.
 - Personally enroll 24 new Distributors with at least 120 PV their first calendar month.
 - Have 8 unique first-level Distributors earn the Quick Start Bonus or Quick Start Bonus 2. A Distributor obtaining both the Quick Start Bonus and Quick Start Bonus 2 only counts towards one unique account for this requirement.
 - Have 4 first-level Distributors achieve the rank of Manager within the calendar year.
 - Enroll 600 or more new Distributors, each with at least 120 PV in their first calendar month, in your first four levels.
 - Have 180 new Quick Start Bonus, or Quick Start Bonus 2 earners in your first four levels.
 - Have 90 Distributors achieve the rank of Manager, for the first time, in your first four levels.
- 120 PV requirements for eligibility can be placed on multiple orders within a calendar month.

- Qualifying participants will be awarded flights and accommodations for four nights and 5 days in Hawaii for themselves and one guest. A guest is an individual 18 years or older. Guests cannot have a beneficial interest in another Xyngular account.
- Qualified Distributors, who are unable to attend Chairman's Circle, will forfeit all trip incentives. See Section 3.19.5 of Xyngular Policies and Procedures.
- The Chairman's Circle trip and other benefits are non-transferable and cannot be exchanged for cash. See Section 3.19.5 of Xyngular Policies and Procedures.
- Xyngular reserves the right to modify trip requirements at any time and will provide 30-day notice to Distributors before any changes become effective.
- Xyngular reserves the right to make changes to trip destinations, inclusions, etc., as needed to accommodate all qualifiers and to ensure the safety of those traveling with the Company.
