

Founders Club 2021 Trip Qualifications

Open to all Distributors, regardless of rank, time with the company, or team size, the 2021 Founders Club trip will be a highlight of the year! There are many different ways to qualify for this memorable trip; these requirements are designed to build and strengthen your business with every point you earn



How to Earn Points

Must have 120 PV to earn points in any given month.⁽³⁾

Points	How to Earn
5 points	Every 1200 PV of inception volume in a calendar month ⁽⁴⁾
5 points	New first-level rank advancement between Manager and Director ⁽⁵⁾
5 points	New first-level Quick Start earner ⁽⁶⁾
2 points	Monthly rank maintenance between Manager and Director ⁽⁷⁾
1 point	Each month with a personal subscription order of at least 120 PV ⁽⁸⁾



Additional Trip Qualification Requirements ⁽⁹⁾

10 unique first-level accounts who advance to a new rank between Manager and Director OR earn a Quick Start Bonus ⁽¹⁰⁾



Founders Club 2021 Event Recognition Qualifications

Quarterly Event Recognition Point Requirements ⁽¹⁰⁾

25 points in a quarter AND three unique first-level rank advancements or Quick Start Bonus earners

Founders Club 2021 Notes

1. One additional night's stay immediately before or after the group trip dates at the Xyngular-booked property. Includes room and tax charges only. If a Distributor qualifies for two additional nights (250 points), they can use both nights before or after the trip, or use one on each end of the trip.
2. Top Point Qualifier must meet all other Founders Club trip requirements to be eligible for the trip and room upgrade.
3. Must have 120 PV each month to receive Founders Club points. If a Distributor has less than 120 PV in any given month, they will forfeit any points earned during that month only.
4. Distributor will receive five points for every 1200 PV of inception volume they personally sponsor in a calendar month. Both Member and Distributor enrollment volume counts toward inception volume totals. Inception volume is defined as the volume from any order placed by a new Member or Distributor during their first calendar month.
5. Distributor will receive five points for every first-time rank advancement for each rank between Manager and Director by a first-level Distributor during the qualification period. For example, if a new first-level Distributor advances to Manager, Silver Manager, and Gold Manager during the period, the sponsoring Distributor would receive five points for each advancement, for a total of 15 points.
6. Distributor will receive five points for each personally enrolled first-level Distributor who earns a Quick Start Bonus during the qualification period.
7. Once a first-level Distributor achieves a new rank, the sponsoring Distributor will receive two points in each additional month that the first-level Distributor maintains their highest attained rank. For example, if a new Distributor advances to Manager, Silver Manager, and Gold Manager, the sponsoring Distributor will only earn maintenance points in months that the first-level Distributor maintains Gold Manager. Only two points per first-level Distributor can be earned each month.
8. Must be a system-generated subscription. An order that processes as a non-subscription order and is later requested to be modified to a subscription order will not count toward this requirement. No exceptions.
9. Unique account credit is given to the sponsor at the time a rank advancement or Quick Start Bonus is earned. In the event someone compresses out of the organization their unique account credits do not roll up and count toward the new sponsor's totals.
10. To qualify for event recognition, Distributor must earn 25 or more points and help three first-level Distributors advance to a new rank, for each rank between Manager and Director; or earn a Quick Start Bonus. For Founders Club qualification purposes, Quarter 1 is October-December, Quarter 2 is January-March, Quarter 3 is April-June, and Quarter 4 is July-September. Quarterly recognition can be earned independent of the Founders Club trip; it is not required to earn 25 points per quarter to qualify for the trip.

Rules

1. Qualification period: October 1, 2020—September 30, 2021
2. Must have a minimum 120 PV each eligible month to qualify for any points during the month.
3. To qualify for the trip and any upgrades, Distributor must achieve total required points (100 or more) and meet all additional trip requirements.
4. Points are awarded to the Distributor who is the direct upline at the time qualification is met. If an account is rolled up to a new upline sponsor, the new upline will only receive points for qualifications met from that date forward.
5. During the qualification period, Distributor must have a minimum of 10 first-level Distributors who advance to a new rank, for each rank between Manager and Director, or earn a Quick Start Bonus.
6. Qualifiers earn a trip for themselves and a guest. A guest is a spouse, significant other, or immediate family member over 18 years old. Guests cannot have a beneficial interest in another Xyngular account.
7. The Founders Club trip, associated upgrades, and other benefits are non-transferable.
8. Xyngular reserves the right to modify trip requirements at any time and will provide 30-day notice to Distributors before any changes become effective.
9. Xyngular reserves the right to make changes to trip destinations, inclusions, etc., as needed to accommodate all qualifiers and to ensure the safety of those traveling with the Company.
10. Open to all Xyngular Distributors.
11. No cash value.
12. Qualified Distributors who cannot attend will forfeit their trip.
13. Any fraudulent activity used to create, advance, or maintain first-level accounts will disqualify you from the trip.
14. Distributor must be in good standing at the time of the trip to redeem.

Event Recognition Rules

Quarterly Recognition Requirement: 25 points AND three first-level rank advancements or Quick Start earners

Qualifiers will receive a \$100 cash award, for each quarter the requirements are met, to offset the costs of attending a Xyngular corporate event (i.e., if a Distributor meets the quarterly requirements for one quarter prior to a corporate event, they will receive a \$100 cash award; if they meet the quarterly requirements for both quarters prior to a corporate event, they will receive a \$200 cash award).

Qualifiers must meet quarterly requirements and attend the event before they will receive the cash award. Qualifiers from quarters 1 and 2 will receive the cash award if they attend Xyngfling; and qualifiers from quarters 3 and 4 will receive the cash award if they attend Xyngfest.

All cash awards will be added to the qualifying Distributor's HyperWallet account within one week following attendance at the corporate event.

Quarterly qualifiers will also receive the following at the event:

- Special Founders Club lanyard and badge
- Founders Club ribbon on event name tag recognizing the quarter of qualification
- Access to the Founders Club Lounge at Xyngfling and Xyngfest
- Founders Club photo
- Reserved seating in one main event session
- Special onstage event recognition
